Board of Directors Meeting November 1, 2023 Fort Wayne, IN

Karen Shaw mentioned that the Spring Meeting minutes did not have the AMHR Carriage Equipment inserted.

(AMHR Tack & Equipment Carriage)

- 1. Light Harness (breast or collar type)
- 2. To be shown in a suitable two or four wheeled carriage pleasure type driving vehicle. Wooden wheels are preferred, Solid spoke or steel wheels are acceptable, Pneumatic wheels permitted, Boot removed.
- Type of bit(s) optional, Snaffle, Liverpools, French Lick, Mullen, Butterfly or Myler are acceptable driving bits. Curb chains or curb straps are allowed and can only be driven in the half cheek. Blinkers appropriate to type of harness.
- 4. Martingales and overchecks are prohibited for all vehicles. False Martingales are acceptable.
- Side checks are optional, breeching or thimbles are required. Tying down of tongues is prohibited. Bridles should fit snugly to prevent catching on the vehicle or other pieces of harness. A throatlatch and a noseband or cavesson is mandatory. Open bridles are permitted but are not encouraged.
- 6. Whip required. The thong (lash) of the whip should be long enough to reach the shoulder of the farther horse.
- 7. Braiding of mane and forelock is optional in any carriage driving class.
- 8. Spares Kits are optional. (Effective January 1, 2024)

Youth Birthday discussion with Show Season

When changed show season – did not think about youth age of animal age. If an animal is a yearling and showed in October 2023 it had to show as a yearling, but on January 1, 2024 it will begin showing as a 2yr old. Discussion on to move the show

season back to the calendar year. Recommended that discussion should be held with membership in the open meetings over the next couple days. Bring back to Saturday meeting.

NSPPR & ASPR divisions

Divisions are not progressing. Discussion held on how to grow these divisions. Committees need to be advised to bring the Board of Directors recommendations.

Andrea Barth gave a brief update for the Super Gelding program. Amy Dalsing and Rebecca Calkins have agreed to chair this program. Andrea Barth will be the Board liaison. The 2024 nomination form and instructions were handed out.

Futurity program. The Association gives \$43,500.00 each year into the futurity program. New members are not aware and do not understand. The committee needs to work on ideas to help promote the program.

Bill Eperthener asked that the Sire & Dam be announced during Congress & Nationals for the champion. Jill will get with programmer to see how we can make this happen.

Discussion on Judges for National Shows. The list of Judges needs to be approved by the Judge's Committee and the recommendation then to the Board of Directors for final approval. Karen Shaw mentioned a few concerns during the AMHR National Show with carriage classes. Wants to split the carriage classes at 15. One of the classes in 2023 was 33 if we split at 15 entries, we will split three times, then if we bring back 6 from each split we would need to split again as there would be 18 from the first three classes. We would run 6 classes to get to the Grand class. Discussion held on placing splits rather than bringing back for the final. Other breeds place splits. Recommend to take this to the membership over the next few days and get their opinion. This will all need to go to the Show Committee to bring recommendations to the Board of Directors at the Spring meeting.

Pony Bucks will be given to the exhibitors for the Grand and Stake classes only in the mandatory National Area Class list. Total to each area would be a maximum of \$3,040.00. The paragraph needs to be cleaned up to state one way. Donna Phillips motioned that the paragraph state Show Managers Must refrain from showing horses/ponies in shows in which they are officiating or employed. Tracey Slagle seconded. Amateur 2023 – 3 Rule passed in Rules Committee meeting 46 Yes – 1 No

Delete - such that family relationship including marriage to or cohabitation with a professional does not automatically disqualify a person from amateur status.

Add – Any person including a family member (as defined at III, Part 1, 14, "Family") of a professional is not an amateur if that person engages in any professional activities as defined herein (III, Part 3, 3.1 A-F; or per youth disqualification below). Simply a family relationship alone (including as a spouse or cohabitant) to a professional does not disqualify a member from amateur status so long as the member is otherwise qualified. Bill Eperthener motioned to make this extraordinary as we do not want to lose amateur exhibitors. Eric Tani seconded. The Amateur Committee proposed an updated Amateur Gelding Incentive and Amateur Jackpot Rules for showing. Discussion held as the rules state everyone in the ring must be an amateur including tailers. This rule failed in 2022 in the general meeting for amateur classes. This is for the Gelding Incentive and Amateur Jackpot classes only not all other amateur classes. Sherri Jolliff motioned to accept proposed rules as written. Alan Dial seconded.
